ΘΕΜΑ: Ευρωπαϊκό Πρόγραμμα «Ορίζοντας Ευρώπη, 2021-2027»: Βραβεία της Ευρωπαϊκής Πρωτεύουσας Καινοτομίας (European Capital of Innovation Awards) (Προθεσμία υποβολής προτάσεων: 30 Ιουνίου 2022)

Το Ευρωπαϊκό Πρόγραμμα Ορίζοντας Ευρώπη είναι το 9ο κατά σειρά πρόγραμμα-πλαίσιο της Ευρωπαϊκής Ένωσης (ΕΕ) για την έρευνα και την καινοτομία για την περίοδο 2021-2027, με προϋπολογισμό 95,5 δισ. ευρώ και αποτελεί το διάδοχο του 8ου προγράμματος πλαίσιο Ορίζοντας 2020 (2014-2020). Ο Ορίζοντας Ευρώπη έχει ως στόχο να συμβάλει στην ενίσχυση της επιστημονικής και τεχνολογικής βάσης της ΕΕ, στην αναμόρφωση του Ευρωπαϊκού Χώρου Έρευνας (ΕΧΕ) και στην βελτίωση της ικανότητας της ΕΕ να καινοτομεί, ενώ αποσκοπεί στη σύνδεση της έρευνας και καινοτομίας με έξι βασικές ευρωπαϊκές προτεραιότητες, που αφορούν στην αντιμετώπιση της κλιματικής αλλαγής, στο ψηφιακό μετασχηματισμό των κοινωνιών και της οικονομίας, στην ευημερία και ασφάλεια των πολιτών, καθώς και στην προστασία της ευρωπαϊκής δημοκρατίας.

Σε αυτό το πλαίσιο, δημοσιεύτηκε πρόσφατα η πρόσκληση υποβολής προτάσεων για τα βραβεία της Ευρωπαϊκής Πρωτεύουσας Καινοτομίας. Το παραδοσιακό οικοσύστημα καινοτομίας της πόλης ανοίγει σε νέα μοντέλα καινοτομίας που προσελκύουν τους πολίτες. Ένας αυξανόμενος αριθμός πόλεων λειτουργούν ως δοκιμαστήρια για την καινοτομία και διεξάγουν πρωτοβουλίες με γνώμονα τους πολίτες για να βρουν λύσεις για τις σχετικές κοινωνικές τους προκλήσεις. Ο δημόσιος τομέας αντιμετωπίζει ιδιαίτερα προβλήματα με την εύρεση αποτελεσματικών τρόπων για τη διασφάλιση της ενσωμάτωσης αυτών των πρακτικών στη συνήθη διαδικασία αστικής ανάπτυξης. Οι επιτυχημένες πρακτικές είναι ιδιαίτερα σημαντικές για την ενίσχυση της ικανότητας της πόλης να προσελκύει νέους πόρους, κεφάλαια και ταλέντα για να τονωθεί η ανάπτυξη πρωτοποριακών καινοτομιών. Επιπλέον, η συνεργασία και η ενίσχυση των συνεργειών μεταξύ των οικοσυστημάτων καινοτομίας ενισχύουν την ανάπτυξη και την ανθεκτικότητα Διανομή μέσω 'ΙΡΙΔΑ' με UID: 6221dc186966d7e682cd712b στις 04/03/22 11:33 των πόλεων για την αντιμετώπιση των αστικών προκλήσεων. Για το λόγο αυτό, τα Βραβεία της Ευρωπαϊκής Πρωτεύουσας Καινοτομίας θα αναγνωρίσουν το ρόλο των πόλεων ως καταλύτες του τοπικού οικοσυστήματος καινοτομίας και θα τονώσουν νέες δραστηριότητες που στοχεύουν στην ενίσχυση της καινοτομίας που αλλάζει το παιχνίδι. Το βραβείο θα ενισχύσει το προφίλ των πόλεων που έχουν αναπτύξει και εφαρμόσει καινοτόμες πολιτικές· έχουν καθιερώσει πλαίσια που ενισχύουν την πρωτοποριακή καινοτομία· έχουν αυξήσει την ελκυστικότητα της πόλης προς τους επενδυτές, τη βιομηχανία, τις επιχειρήσεις και τα ταλέντα· έχουν βοηθήσει στο άνοιγμα των συνδέσεων και στην ενίσχυση των δεσμών με άλλες πόλεις, προωθώντας την αναπαραγωγή των βέλτιστων πρακτικών στον τομέα της καινοτομίας· έχουν ενισχύσει τη συμμετοχή των πολιτών στη διαδικασία λήψης αποφάσεων· και έχουν υποστηρίξει την ανθεκτικότητα των πόλεων.

Στο διαγωνισμό μπορούν να συμμετάσχουν οι πόλεις όλων των κρατώνμελών ή των χωρών που είναι συνδεδεμένες στο ερευνητικό πρόγραμμα της ΕΕ («Ορίζοντας Ευρώπη»). Το βραβείο της Ευρωπαϊκής Πρωτεύουσας Καινοτομίας απονέμεται <u>σε πόλεις με περισσότερους από 250.000 κατοίκους</u>. Το δε βραβείο της Ευρωπαϊκής Αναδυόμενης Πόλης της Καινοτομίας θα απονεμηθεί <u>σε πόλη με πληθυσμό από 50.000 έως 249.999 κατοίκους</u>.

Η νικήτρια πόλη που θα επιλεγεί για το βραβείο της Ευρωπαϊκής Πρωτεύουσας Καινοτομίας θα λάβει 1.000.000 ευρώ, ενώ οι επιλαχούσες, η δεύτερη και η τρίτη πόλη κατά σειρά, θα λάβουν χρηματικά βραβεία ύψους 100.000 ευρώ. Η δε νικήτρια πόλη που θα επιλεγεί για το βραβείο της Ευρωπαϊκής Αναδυόμενης Πόλης της Καινοτομίας θα λάβει 500.000 ευρώ, ενώ οι επιλαχούσες, η δεύτερη και η τρίτη πόλη κατά σειρά, θα λάβουν χρηματικά βραβεία ύψους 50.000 ευρώ.

Η προθεσμία υποβολής προτάσεων λήγει στις 30 Ιουνίου 2022.



0. Introduction

This is a call (contest)¹ for an EU recognition **prize** in the field of innovation under the **Horizon Europe Framework Programme for Research and Innovation**.

The regulatory framework for this EU Funding Programme is set out in:

- Regulation 2018/1046 (EU Financial Regulation)
- the basic act (Horizon Europe Regulation(EU) 2021/6952)

The call is launched in accordance with the 2022 <u>European Innovation Council (EIC)</u> <u>Work Programme³ and is managed by the European Innovation Council and SMEs Executive Agency ('Agency').</u>

We invite you to read the **call documentation** on the Funding & Tenders Portal Topic page carefully, and in particular these Rules of Contest as well as the <u>EU Funding & Tenders Portal Online Manual</u>.

These documents provide clarifications and answers to questions you may have when preparing your application:

- the Call Document (Rules of Contest) outlines the:
 - background, objectives, scope, activities that can be funded and the expected results (sections 1 and 2)
 - available budget and timetable (sections 3 and 4)
 - admissibility, eligibility (including mandatory documents, sections 5 and 6)
 - criteria for exclusion (section 7)
 - evaluation and award procedure (section 8)
 - award criteria (section 9)
 - other conditions (section 10)
 - how to submit an application (section 11)
- the <u>Online Manual</u> outlines the procedures to register and submit applications online via the EU Funding & Tenders Portal ('Portal').
- You are also encouraged to visit the official <u>website</u> to consult the list of prizes funded previously.

For ease of reference and consistency on the Funding & Tenders Portal, the terms 'call', 'project' and 'participant' are used as equivalent to 'contest', 'application' or 'contestants/applicants'.

Regulation (EU) 2021/695 of the European Parliament and of the Council of 28 April 2021 establishing Horizon Europe – the Framework Programme for Research and Innovation, laying down its rules for participation and dissemination, and repealing Regulations (EU) No 1290/2013 and (EU) No 1291/2013 OJ L 170/1 of 12.05.2021.

Commission Implementing Decision C(2022) 701 of 7 February 2022 on the financing of the European Innovation Council component of the Specific Programme implementing Horizon Europe – the Framework Programme for Research and Innovation (2021-2027) and on the adoption of the Work Programme for 2022.

1. Background

Cities are faced with some of the most severe societal and sustainability challenges, but do also have the means to develop and apply effective innovative solutions. They are the place where ideas, people, public and private actors meet and interact to improve the quality of citizens' lives. They are the natural playground where breakthrough innovation can flourish and nourish. They provide ground to experiment new technologies and products in a real environment, their interaction with people and their added-value.

With their capacity to connect people, places, public and private actors, cities can substantially boost innovation in Europe while ensuring a better future for all. New approaches to undertake and deploy innovative practices are gaining support, making the shift from traditional top-down schemes to more open and bottom-up practices.

2. Objectives - Themes and priorities - Activities - Expected results

Objectives

The traditional city innovation ecosystem is opening up to new models of innovation engaging citizens. An increasing number of cities are acting as test beds for innovation and run citizens-driven initiatives to find solutions for their relevant societal challenges.

The public domain is particularly challenged with finding effective ways to ensure the mainstreaming of these practices into the ordinary urban development process. Successful practices are particularly crucial to enhance the city's capacity to attract new resources, funds and talents to stimulate the growth of breakthrough innovations. Moreover, collaboration and strengthening synergies among innovation ecosystems boost cities' development and resilience to tackle urban challenges.

For this reason, the European Capital of Innovation Awards will recognize the cities' role as catalysers of the local innovation ecosystem and will stimulate new activities aimed at boosting game-changing innovation.

Expected results

The European Capital of Innovation Awards aim to **champion** inspiring cases of municipality-enabled innovation flourishing in cities. The Awards are a **prestigious recognition** for city administrators who are courageous enough to open up their governance practices to experimentation, to boost innovation by all means, to be a role model for other cities, and to push the boundaries of technology for the benefit of their citizens.

In addition to the monetary reward, the prize brings **high visibility** in the form of renewed public interest and increased media coverage.

A European prize to the most innovative cities ecosystems. The award will raise the profile of the cities that have developed and implemented innovative policies; established frameworks that boost breakthrough innovation; enhanced the city attractiveness towards investors, industry, enterprises and talents; helped to open up connections and strengthen links with other cities, promoting the replication of best practices in the innovation field; enhanced citizens' involvement in the decision-making process; and supported cities resilience.

The Awards will feature two categories:

A) European Capital of Innovation 2022 category:

- <u>1 winner:</u> the winner (ranked 1st) will be named the <u>European Capital of Innovation 2022</u> and will receive a <u>prize of EUR 1 million</u>. The prize is dedicated to <u>recognise</u> the winning city's innovative practices, <u>raise its international profile</u>, and enhance its capacity as a widely recognised <u>role model city</u> for urban innovation.
- <u>2 runners-up cities</u>: top two cities (ranked 2nd and 3rd) with the most disruptive innovation practices that lead to outstanding impact will be awarded each a prize of 100 000 EUR.

B) European Rising Innovative City 2022 category:

• 1 winner: the winner (ranked 1st) will be named the European Rising Innovative City 2022 and will receive a prize of EUR 500 000. The prize is dedicated to recognise the winning city's innovative practices, raise its international profile, and enhance its capacity as a widely recognised role model city for urban innovation.

2 runners-up cities: top two cities (ranked 2nd and 3rd) with the most disruptive innovation practices that lead to outstanding impact will be awarded each a **prize** of 50 000 EUR.

3. Available budget

One first prize for the winner of the European Capital of Innovation category of EUR 1 000 000, and two runner-up prizes of EUR 100 000 for the top two cities (ranked 2^{nd} and 3^{rd}).

One first prize for the winner of the European Rising Innovative City category of EUR 500 000, and two runner-up prizes of EUR 50 000 for the top two cities and towns (ranked 2nd and 3rd).

5. Admissibility

Applications must be submitted before the call deadline (see timetable section 4).

Applications must be submitted **electronically** via the Funding & Tenders Portal Electronic Submission System (accessible via the Topic page in the <u>Search Funding & Tenders</u> section). Paper submissions are NOT possible.

Applications (including annexes and supporting documents) must be submitted using the forms provided *inside* the Submission System (\triangle NOT the documents available on the Topic page — they are only for information).

Applications must be **complete** and contain all the requested information and all required annexes and supporting documents:

- Application Form Part A contains administrative information about the applicant organisations (to be filled in directly online)
- Application Form Part B contains the technical description of the application (to be downloaded from the Portal Submission System, completed and then assembled and re-uploaded as PDF in the system)
- mandatory annex (to be uploaded as PDF file):
 - Each application must contain a specific endorsement to apply, signed by the city Mayor (or the equivalent highest political representative) of maximum 2 pages. The required level of representation has to be respected.

Your application must be readable, accessible, printable.

Applications are limited to **30 pages** (Part B). Evaluators will not consider any additional pages.

You may be asked at a later stage for further documents (for legal entity validation, bank account validation, ethics review, declaration of honour, etc).

6. Eligibility

Eligible participants

In order to be eligible, the applicant has to be a city and must comply with all the following criteria:

- The candidate cities must be located in one of the EU Member States or Associated Countries to Horizon Europe, and
- 2. For the category of European Capital of Innovation, the candidate city must have a population of minimum 250 000 inhabitants. In countries where there are no such cities, the city coming closest to 250 000 inhabitants is eligible to apply for the European Capital of Innovation category, provided that it has a minimum population of 50 000 inhabitants and that the city did not apply for the European Rising Innovative City category. The candidate cities for the European Rising

Innovative City category must have a population of 50 000 and up to 249 999 inhabitants.⁴

- 3. Winners of former European Capital of Innovation Awards editions, as well as runners-up of the edition organised one year prior to the current edition are not eligible. This does not apply to previous finalist cities.
- 4. Applicants that have already received an EU or Euratom prize cannot receive a second prize for the same activities.

All applicants must register in the <u>Participant Register</u> — before the call deadline — and will have to be validated by the Central Validation Service (REA Validation). For the validation, you will be requested to upload documents showing legal status and origin.

Specific cases

Entities without legal personality — Entities which do not have legal personality under their national law may exceptionally participate, provided that their representatives have the capacity to undertake legal obligations on their behalf, and offer guarantees for the protection of the EU financial interests equivalent to that offered by legal persons⁵.

Third countries currently negotiating association agreements to Horizon Europe — Applicants from countries with ongoing negotiations may participate in the call and can receive a prize if the Horizon Europe association agreement with the third country concerned applies at the time when the award decision is taken (see General Annex B to the Horizon Europe main Work Programme).

EU bodies — EU bodies (with the exception of the European Commission Joint Research Centre) can NOT apply.

EU restrictive measures — Special rules apply for certain entities (e.g. entities subject to <u>EU restrictive measures</u> under Article 29 of the Treaty on the European Union (TEU) and Article 215 of the Treaty on the Functioning of the EU (TFEU)⁶ and entities covered by Commission Guidelines No <u>2013/C 205/05</u>⁷). Such entitles are not eligible to participate in any capacity.

Eligible activities

Eligible activities are the ones set out in section 2 above.

⁴ For the purposes of this competition, a 'city' is an urban area understood as an administrative unit governed by a city council or another form of democratically elected body. For population data, Eurostat will be the source of reference (for countries not covered by Eurostat, the Agency may perform specific checks when assessing the eligibility criteria). For countries not covered by Eurostat, the Agency will perform specific checks when assessing the eligibility criteria, and might ask any concerned cities to prove they comply with this requirement.

Geographic location (target countries)

Applications must relate to activities in an EU Member State or an Associated Country to Horizon Europe.

Ethics and values

Activities must comply with the highest ethical standards and the applicable EU, international and national law on ethical principles.

Moreover, they must respect basic EU values (such as respect for human dignity, freedom, democracy, equality, the rule of law and human rights, including the rights of minorities).

The activities must comply with:

- ethical principles (including the highest standards of research integrity) and
- applicable international, EU and national law

and may not:

- aim at human cloning for reproductive purposes
- intend to modify the genetic heritage of human beings which could make such changes heritable (with the exception of research relating to cancer treatment of the gonads, which may be financed), or
- intend to create human embryos solely for the purpose of research or for the purpose of stem cell procurement, including by means of somatic cell nuclear transfer.

Moreover activities must have an exclusive focus on civil applications and no prize can be awarded for activities carried out outside the EU, if they are prohibited in all Member States.

Applications involving ethics issues will have to undergo an ethics review to authorise funding. Applications that did not respect the above ethical principles and standards cannot be awarded a prize.

Security

Applications involving EU classified information must comply with Decision 2015/444. Applications that are too security-sensitive cannot be awarded a prize.

7. Exclusion

Applicants which are subject to an **EU exclusion decision** or in one of the following **exclusion situations** that bar them from receiving EU funding can NOT participate⁸:

- bankruptcy, winding up, affairs administered by the courts, arrangement with creditors, suspended business activities or other similar procedures (including procedures for persons with unlimited liability for the applicant's debts)
- in breach of social security or tax obligations (including if done by persons with unlimited liability for the applicant's debts)

See Articles 136 and 141 EU Financial Regulation 2018/1046

- guilty of grave professional misconduct⁹ (Including if done by persons having powers of representation, decision-making or control, beneficial owners or persons who are essential for the award/implementation of the prize)
- committed fraud, corruption, links to a criminal organisation, money laundering, terrorism-related crimes (including terrorism financing), child labour or human trafficking (including if done by persons having powers of representation, decision-making or control, beneficial owners or persons who are essential for the award/implementation of the prize)
- shown significant deficiencies in complying with main obligations under an EU procurement contract, grant agreement, prize, expert contract, or similar (including if done by persons having powers of representation, decision-making or control, beneficial owners or persons who are essential for the award/implementation of the prize)
- guilty of irregularities within the meaning of Article 1(2) of Regulation No 2988/95 (including if done by persons having powers of representation, decision-making or control, beneficial owners or persons who are essential for the award/implementation of the prize)
- created under a different jurisdiction with the intent to circumvent fiscal, social or other legal obligations in the country of origin or created another entity with this purpose (including if done by persons having powers of representation, decision-making or control, beneficial owners or persons who are essential for the award/implementation of the prize).

Applicants will also be refused if it turns out that10:

- during the award procedure they misrepresented information required as a condition for participating or failed to supply that information
- they were previously involved in the preparation of the call and this entails a distortion of competition that cannot be remedied otherwise (conflict of interest).

8. Evaluation and award procedure

Applications will be subject to a formal evaluation by a jury in each category.

If there are more than 60 applications in one category, there will be a pre-selection phase in that category to select the best 60 applications to pass to the jury review. Otherwise, all eligible applications will pass directly to jury review.

The pre-selection panel and jury usually have a different composition, but jury members may participate in the pre-selection panel.

The pre-selection panel/jury will evaluate each application against the award criteria.

For applications with the same score, the pre-selection panel/jury will determine a **priority order** according to the following approach: the score for the criterion No 3 will be given a weight of 2 and the score for criterion No 1 will be given a weight of 1.5. If two or more applications still tie for any rank or category, the prize will be equally divided and awarded to all applications with the same score.

See Article 141(1) EU Financial Regulation 2018/1046.

Professional misconduct includes: violation of ethical standards of the profession, wrongful conduct with impact on professional credibility, false declarations/misrepresentation of information, participation in a cartel or other agreement distorting competition, violation of IPR, attempting to influence decision-making processes or obtain confidential information from public authorities to gain advantage.

In addition, up to 6 best ranked applications in each category will be invited for a hearing with the jury in Brussels. This hearing may take place remotely.

On the basis of the evaluation by the jury (and after the mandatory checks: ethics review, security scrutiny, legal entity validation, non-exclusion, double funding and plagiarism, etc), the awarding authority will decide on the award of the prize.

All applications will be informed about the evaluation result (evaluation result letter). Successful applications will be awarded the prize; the not successful ones will be rejected.

If you believe that the evaluation procedure was flawed, you can submit a **complaint** (following the deadlines and procedures set out in the evaluation result letter). Please note that notifications are deemed to have been accessed (and received) 10 days after sending and that deadlines will be counted from then (see also <u>Funding & Tenders Portal Terms and Conditions</u>).

9. Award criteria

If admissible and eligible, the applications will be evaluated and ranked against the following award criteria:

- award criterion 1: Experimenting innovative concepts, processes, tools, and governance models proving the city's commitment to act as a test-bed for innovative practices, while ensuring the mainstreaming of these practices into the ordinary urban development process.
- award criterion 2: Escalating accelerating the growth of highly innovative start-ups and SMEs by establishing an innovation friendly legal framework, creating an environment that stimulates growth, private and public investments, resources, diversity and talents; and driving innovation demand through efficient innovation public procurement. The city is expected to provide details on concrete results of the showcased initiatives.
- award criterion 3: Ecosystem building unlocking the city's potential as local innovation ecosystem facilitators by fostering synergies among different innovation ecosystem players, from public, industry, startups, civil society, citizens to academia, to contribute to the development of an innovation ecosystem within the city.
- award criterion 4: Expanding acting as a role model for other cities by supporting the dissemination and replication of tested solutions that boost the local innovation ecosystem; by promoting mutual learning, knowledge transfer and capacity building; and by enhancing cooperation and synergies between cities that are front-runners in driving the local innovation ecosystem, and those that are still exploring and testing their role as innovation enablers.
- award criterion 5: City Innovative vision applicants should demonstrate their long-term strategic vision/plan, highlighting the innovative initiatives that have positively contributed to the transformation of the city and which will further support the development of a sustainable and resilient innovation ecosystem ensuring the green and digital transitions.

Applications must pass both all the individual thresholds AND the overall threshold. The prize will be awarded to the applications ranked 1st, 2nd, and 3rd with the best scores in each category. Other applications will be rejected.

10. Other conditions

Payment arrangements

The prize money will be paid to the prize winners after the award ceremony, provided all the requested documents have been submitted.

Communication — Dissemination — Visibility of funding

Prize winners must promote the prize and its results, by providing targeted information to multiple audiences (including the media and the public) in a strategic and effective manner.


Communication activities related to the prize (including media interviews, press statements, presentations, etc., in electronic form, via traditional or social media, etc.), must acknowledge EU support and display the European flag (emblem) and funding statement (translated into local languages, where appropriate):





The emblem must remain distinct and separate and cannot be modified by adding other visual marks, brands or text.

Apart from the emblem, no other visual identity or logo may be used to highlight the EU support.

When displayed in association with other logos (e.g. of winners or sponsors), the emblem must be displayed at least as prominently and visibly as the other logos.

For the purposes of these obligations, the winners may use the emblem without first obtaining approval from the awarding authority. This does not, however, give them the right to exclusive use. Moreover, they may not appropriate the emblem or any similar trademark or logo, either by registration or by any other means.

Any communication or dissemination activity related to the prize must use factually accurate information.

Moreover, it must indicate the following disclaimer (translated into local languages where appropriate):

"Funded by the European Union. Views and opinions expressed are however those of the author(s) only and do not necessarily reflect those of the European Union or of the European Innovation Council and SMEs Executive Agency. Neither the European Union nor the awarding authority can be held responsible for them."

IPR - Rights of use

The awarding authority does not obtain ownership of the results produced in the context of the prize.

The awarding authority has the right to use non-sensitive information relating to the prize and materials and documents received from the winners (such as pictures or audiovisual material, in paper or electronic form) for information, communication, dissemination and publicity purposes.

Photos and videos taken by the awarding authority either in preparation of the award

ceremony or during the award ceremony are the sole property of the awarding authority.

Additional communication, dissemination and exploitation obligations

Following the announcement of finalist cities after the hearings, all finalist cities will be requested to provide pictures and a one-minute video displaying the city's innovative practices in an attractive way. The European Commission and the Agency will use those videos and pictures at the award ceremony and other relevant occasions to promote the prize and the finalist/awarded cities.

Checks, audits and investigations

The awarding authority, the European Commission, the European Anti-Fraud Office (OLAF), the European Public Prosecutor's Office (EPPO) and the European Court of Auditors (ECA) may carry out checks, audits and investigations in relation to the prize.¹¹

Withdrawal of the prize — Recovery of undue amounts

The awarding authority may withdraw the prize after its award and recover all payments made, if it finds out that:

- false information, fraud or corruption was used to obtain it
- the prize winners were not eligible or should have been excluded or
- the prize winners are in serious breach of their obligations under these Rules of Contest.

11. How to submit an application

All applications must be submitted directly online via the Funding & Tenders Portal Electronic Submission System. Paper applications are NOT accepted.

You can access the Portal here, or by clicking 'Apply now' on the official prize webpage.

Submission is a 2-step process:

a) create a user account and register your organisation

To use the Submission System (the only way to apply), all participants need to <u>create an EULogin user account</u>.

Once you have an EULogin account, you can <u>register your organisation</u> in the Participant Register. When your registration is finalised, you will receive a 9-digit participant identification code (PIC).

b) submit the application

Access the Electronic Submission System via the Topic page in the <u>Search Funding & Tenders</u> section.

Submit your application in 3 parts, as follows:

- Part A includes administrative information about the applicant organisations . Fill it in directly online
- Part B (description of the action) covers the technical content of the application.
 Download the mandatory word template from the Submission System, fill it in and upload it as a PDF file
- Annex (see section 5). Upload it as a PDF file.

The application must keep to the page limits (see section 5); excess pages will be disregarded.

Documents must be uploaded to the **right category** in the Submission System otherwise the application might be considered incomplete and thus inadmissible.

The application must be submitted **before the call deadline** (see section 4). After this deadline, the system is closed and applications can no longer be submitted.

Once the application is submitted, you will receive a **confirmation e-mail** (with date and time of your application). If you do not receive this confirmation e-mail, it means your application has NOT been submitted. If you believe this is due to a fault in the Submission System, you should immediately file a complaint via the <u>IT Helpdesk</u> webform, explaining the circumstances and attaching a copy of the application (and, if possible, screenshots to show what happened).
